REQUEST FOR PROPOSAL(RFP) FOR FURNITURES

Sealed guotations are invited for entering Into Annual Rate Contract (ARC) with the manufactures and or their authorized dealers for procurement of Office Furniture, Modular Furniture, Health Care Furniture, Seating Products, and Classroom Furniture for **IISER** Pune and **IISER** Tirupati. Interested Vendors may Sealed Envelop in two bid system superscribed "PROPOSAL their proposals in FOR RATE CONTRACT FOR FURNITURE" along with Price list indicating the discount, taxes, delivery period, F.O.R. etc on or before 8.4.2015.

Terms & Conditions

The terms & conditions as mentioned below would be binding to all the parties:

- 1. Rate Contract will be accepted only from the manufacturers or their Authorized Distributors.
- 2. The manufacturers should send document of registration of companies with a copy of product license, Income Tax, PAN No. and recent authorization certificate of the manufacturer in case of authorized dealer.
- 3. The period of contract will be One Year from the date of signing of Contract.
- 4. The rates of the products shall be FOR Destination (FOR) IISER Pune and IISER Tirupati offered at the time of entering into Rate Contracts will be final, it will include delivery, installation, proper furniture fixing at site.
- 5. The Earnest Money Deposit(EMD) of Rs.1,00,000.00(one lakh) should be attached along with rate Technical Bid in the form of Demand Draft drawn in favour of "DIRECTOR IISER Pune" Payable at Pune Only. The EMD so deposited shall be refund to unsuccessful bidders on award of ARC. EMD can be deposited in the form of BG from any of Indian scheduled Bank with validity of min. 3 Months.
- 6. All rights are reserved with the Institute Authority to accept or reject any or all the quotations without assigning any reasons thereof.
- 7. Prequalification/Eligibility Criteria for annual rate contract in respect of furniture is enclosed as Annexure A.
- 8. Interested vendors may submit their applications superscribing "Proposal for Annual Rate Contract for Furniture" to the Assistant Registrar, IISER Pune, Dr Homi Bhaba Road, Pashan, Pune 411008 latest by 8.4.2015 up to 3.00 PM.
- 9. The bid must be submitted in two bid system comprising of the technical bid and Financial bid .The Technical Bid must contain the EMD and will be Opened First and based on the qualification the price bid shall be opened .Tender submitted in single tender shall be rejected.
- 10. The standard /current price list should be submitted along with the commercial bid.
- 11. Items covered under the rate list shall be ordered, in case of qualification of technical bid. The products should be available in the showroom also.
- 12. No Catalogs to be attached to The Tender. ONLY CD's may be submitted for evidence.
- 13. Delivery of Tender: The original copy of the tender form is to be enclosed in two separate envelopes, the envelope containing Annexure I and II marked as "Techno-Commercial bid" /and another envelope containing only Financial Details marked as "Price bid". The two envelopes should be sealed and should



- bear address of the office, tender enquiry no, due date and time. The two envelopes should be put in one envelope and addressed to Assistant Registrar (S&P), Indian Institute of Science Education & Research , Dr. Homi Bhaba Road, Pashan, Pune 411008, India marked with our tender enquiry number and due date.
- 14. The tenderer should quote in figures as well as in words the rate and amount tendered by them in the financial bid.
- 15. Telegraphic, conditional or incomplete tenders will not be accepted. Canvassing of any kind, direct or indirect, shall lead to disqualification of the tenderer.
- 16. Tender in any form other than the prescribed form issued by IISER PUNE will not be entertained and will be summarily rejected.
- 17. After opening of the Technical and Commercial Bid, the commerical bid cannot be revised/modified. In such cases the tender will be summarily rejected and the entire Earnest Money deposit submitted with the tender will be forfeited.
- 18. The time and date of opening of Commercial Bids shall be intimated later. The commercial bids of only those tenderers will be opened who are declared qualified by the Technical Committee.
- 19. The technical qualification of bidder does not give right to vendor or manufacturer to have any confirm order from IISER Pune.
- 20. IISER Pune reserves the right to have selection of furniture from any company/manufacturer depending upon the design, requirement of furniture by end user and technical specification of the furniture. No claim from any vendor shall be entertained by IISER Pune.
- 21. Depending upon the requirement, order will be placed by IISER Pune. The purchase committee would be competent authority to decide the furniture order.
- 22. The order may be placed with multiple vendors. IISER Pune is not bound to place order with vendor giving high discount on price list under commercial bid.
- 23. The rate contract may be renewed for a further period of one year based on the quality and satisfactory supply/services during the currency of contract.
- 24. As the vendor has to supply in two cities i.e Pune and Tirputi, all the statutory levies, taxes are to be made as per state regulations.
- 25. Payment shall be released to the Firm on successfully delivery, Installation of the furniture within 30 days.
- 26. PENALTY CLAUSE: In case of any delay in delivery and installation of the furniture items within the time period as agreed upon, IISER PUNE shall have the right to claim penalty for late delivery& installation & commissioning @.5% of the contract value per week subject to a maximum of 10% or more as to be decided by Director, IISER PUNE. The rate of penalty changes may go beyond 10% depending the magnitude of delay and non compliance of the commercial terms & conditions. The same penalty rate shall be leviable in case of delay in corresponding installation & commissioning.
- 27. ARBITRATION: All disputes arising out of this contract shall be referred to the sole arbitration of the Director, IISER PUNE or his nominee as per the provisions of Indian Arbitration and reconciliation Act 1996 and his award shall be final and binding on the parities to the dispute. The venue of arbitration shall be decided by the Director of the institute.



- 28. Jurisdiction: The disputes, legal matters, court matters, if any, shall be subject to Pune Jurisdiction only.
- 29. Director IISER PUNE reserves all rights to ignore any tender who fails to comply with the above instructions.
- 30. Director IISER PUNE reserves the right to accept or reject or cancel any or all enquiries or quotations at any stage without assigning any reason thereof.



ANNEXURE - A

ELIGIBILITY/ PRE QUALIFICATION FOR FURNITURE

Eligibility Conditions: Manufacturer, who will be able to meet the following criteria are only eligible to apply:

- 1. The firm should be OEM (Original Equipment Manufacturer) must be in this business for last 10 years or more.
- 2. The Bidder should have Annual Turnover of minimum 10 crore for last 3 consecutive years and Audited Balance sheet must be submitted along with a statement of account by C.A (Charted Accountant). ARC shall be finalized with OEM'S or their authorized Dealer/ Distributors Only.
- 3. Manufacturer will agree on to undertake comprehensive warranty for a period of one year for all the items supplied of fixed by it and it shall also agree for three years post warranty services and maintenance under annual Maintenance contract (AMC) price may be quoted separately for this.
- 4. Manufacturing bidders should be a certified ISO-9001 organization and considering IISER PUNE'S and IISER TIRUPATI'S growing concern on environment and human resource, the furniture manufacturer should also posses ISO-14001 and OHSAS18001. All these must be submitted with the tender (Technical bid). The supporting documents to be enclosed.
- 5. The furniture manufacturer should have an organized service set up based at Pune and Tirupati. First Response Time for service should be within 24 working hours (excluding Sundays/ holidays) Detailed address to be Submitted.
- 6. The manufacturer should have in house Quality Control Facility. (Supporting documents about Quality Control facilities). Documents to be submitted.
- 7. The weight-age will be given to the manufacturers having BIFMA certificate.
- 8. Black listed: The bidder shall not be among the ones blacklisted for any reason in any government /public sector organization. Affidavit to be submitted to that effect.
- 9. Permanent account number: PAN must attach the copy. (Documentary evidence should be attached).
- **10.** Service tax registration: As per applicability (Documentary evidence should be attached).
- 11. TIN Registration No: VAT/CST as per applicable. (Documentary evidence should be attached)
