GENERAL TERMS AND CONDITIONS

Terms and Conditions:-

- 1. The Pharmacy / Agency shall maintain separate record and register for the medicines supplied to IISER Tirupati employees and dependant family members.
- 2. IISER requires that the bidder under this bid observes the highest standard of ethics during the procurement and execution of such contract.
- 3. IISER will reject the proposal for award if it determines that the bidder recommended for award is engaged in corrupt or fraudulent practices in competing for the contract in question.
- 4. The bidder should quote uniform discounts in percentage terms on the maximum retail price (MRP) inclusive of all taxed printed on the strip / bottle / unit packed in respect of all items of supplies to be made under the contract. The quoted offer shall be on the MRP inclusive of all taxes and shall remain fixed for the entire period of contract.
- 5. The pharmacy/agency will issue drugs based on the prescription in original authorized and issued by IISER Dispensary Doctors. (Doctors from CGHS recognized hospitals and doctors from hospitals recognized by IISER as the case may be). List of IISER recognized hospitals will be provided. The Pharmacy will be required to supply the medicines after obtaining signature on the reverse of the prescription from the person concerned as a token of acknowledgement for having supplied the medicines from the pharmacy. The pharmacy will supplement short of medicines if any, at a short notice.

- 6. The pharmacy will submit the bill fortnightly along with the prescription duly signed by the person who received the medicines.
- 7. The medicines supplied should be (manufacturing date/batch) out of fresh stock with a maximum expiry period. Pharmacy will supply only branded medicines.
- 8. IISER will release payment within a 30 days from the date of receiving the bill from pharmacy / agency.
- **9**. The pharmacy will make available all registers and records for verification / authentication to the Competent Authorities of IISER as and when required.
- 10. The pharmacy will prepare and submit consolidated bill to IISER Dispensary for employees and their dependent family members showing in separate Excel Sheet for each category of employees).
- 11. Any change or modification to this agreement will necessarily require being in writing upon mutual understanding of both the parties to this agreement.

Both the parties understand that during the term of this agreement, there would be exchange of information between them with regard to highly confidential patient data. During this term of this agreement, and following the expiration or termination thereof, none of the mentioned parties shall cause its officers, agents and affiliates to disclose any confidential information, to any third party(s).

COMMENCEMENT AND TERMINATION

- 1. The above agreement will be for a period of <u>TWO</u> years from the date of award of contract. The Agreement may be extended depending upon satisfactory services on the same terms and conditions as are mutually agreed upon.
- 2. This agreement may be terminated on any of the following contingencies:
 - a. On the expiry of the contract period as stated above
 - b. By giving one week's notice by IISER on account of
 - i. Committing breach by Pharmacy / Agency of any of the terms and conditions of this Agreement and
 - ii. On assigning any contract benefit or interest therein or any part thereof by Pharmacy / Agency to any third person or subletting whole or part of

the said work to any third person / party without written permission of IISERT

c. On Pharmacy / Agency being declared insolvent by competent court of law

During the notice period for termination of the contract, in the situation contemplated above, Pharmacy / Agency shall keep on discharging his duties till the expiry of notice period.

ARBITRATION

- 1. In the event of any question, dispute or difference arising under or in connection herewith, the same shall be referred to the sole arbitration to Director, IISER Pune or his nominee.
- 2. The award of the Arbitrator shall be final and binding on the parties. In the event of such Arbitrator to whom he matter is originally referred is being transferred or vacating his office or in the event of his resigning or refusing to work or neglecting his work or being unable to act for any reason whatsoever, the Director shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.
- 3. The Arbitrator may give interim award and / or directions in the interest of justice.
- 4. Subject to the aforesaid provisions, the Arbitration & Conciliation Act, 1996 and the rules made hereunder and any modifications thereof from time to time being in force shall be deemed to apply to the arbitration proceeding under this clause.
