Inclusion of IPv4-to-IPv6 (NAT46) and IPv6-to-IPv4 (NAT64) compliance was suggested for products to be offered.	No Change in tender specification It is difficult to check the Stateful / Stateless NAT64 and NAT46 translations offered by the products / items to validate the compliance of the UTM/Firewall as it requires supporting network infrastructure. In view of the fact that IPV6 configurations is proliferating in the ISP networks it is pertinent to foresee the usability of IPv4-to-IPv6 (NAT46) and IPv6-to-IPv4 (NAT64). Bidders are essentially required to note that the feature of Stateful / Stateless NAT64 and NAT46 shall be required to be complied with in near future.
5.	Request for amendment to point no 6, under specifications WAF- 'K'- 'It should be capable of providing served URL hardening with configurable deep-linking and directory traversal prevention.' Page no. 29.	Accepted. The amended specification may now please be read as - 'It should be capable of providing served URL hardening and directory traversal prevention.'
6.	To Meet, the correct sizing of email security solution following is requested:	1. The total number of mail user accounts = 600 with possibility to cater 1000 without additional cost.
