XY lateral noise ≤ 0.05nm (vertical, closed loop), Z scanner max. range: 5-15μm Vertical Z noise ≤ 0.02nm Scanner. The scanners should be with Piezo sensors in all X, Y and Z. The offered scanners must support all imaging modes and during environmental and temperature studies. Scanners should be leak resistant.

4	Page No - 25, Chapter 4 Point 8 Under Controller Electronics: Suggestion by one bidder "is it ok if we provide slightly and better electronics than tendered specification."	Better specifications than tendered specifications will comply.
