S.No	Query/Clarification Sought	Clarification / Amendment
1	Chapter 4; Page 23 Query: IISER tender states Automatic pressure control with no manual intervention.	Chapter 4; Page 23 As per the Pre-bid discussion, this has been changed to Automatic pressure control along with manual pedal control.
2	Chapter 4; Page 24 Query: IISER tender states highly efficient vacuum pump with flow more than 20 Cu.m/hr. Can this be reduced?	Chapter 4; Page 24 The minimum flow rate should at least be between 12 and 15 Cu,m/hr
3	Chapter 4; Page 24 Query: The IISER tender did not specify the blower speed in the purification section. Can this be specified?	Chapter 4; Page 24 The maximum flow rate required is in the range of 95-110 m <sup>3</sup> /h (CFM). These flow rates should be variable as per various purification and handling needs.
4	Chapter 4, Page 24 Query: IISER tender states the sound level should be below 49 dB. Can this be higher?	Chapter 4, Page 24 The sound level can be at a maximum limit of 60 dB.
5	Chapter 4, Page 25 Query: IISER tender states the O <sub>2</sub> and H <sub>2</sub> O analyzers should be in the measuring range of 0-23000 ppm. Can the maximum detection limit be changed?	Chapter 4, Page 25 This range can be changed to 0-1000 ppm and higher.
