Corrigendum: A Corrigendum Dated 19/02/2021 was published clarifying the tendered bidder's past experience criterion.

Against this bid enquiry, a total of 2 (Two) bid responses were received (given below).

For all the above; upon assessment of the proposals received based on the documents submitted by the bidders, below are the findings:

1. Mega Networks Pvt. Ltd.

a. The Bidder has included MSME certificate with the Bid which does not notify it to be manufacturer of the tendered class / category of products. Upon inspection of the documents it was found that bidding firm is not the Original equipment manufacturer of the product / items. The bidder is acting to the capacity of authorized agent for FusionStor Technologies

Pvt. Ltd., (Claimed OEM of the product chose to bid). From the copies of executed past purchase orders as attached with the bid document, the experience of having supplied GPU based Rack servers cannot be ascertained (in contravention to the corrigendum published to the tender).

b. The exemption under public procurement policy as a prequalification criterion cannot be allowed to traders / resellers of the product item chose to bid.

The bid thereby stands 'Technically dis-qualified'.

2. SRSG Broadcast India Pvt. Ltd.

- a. The bid was submitted acting as an Authorized dealer (Not as a manufacturer) of product item. The Bidder has included MSME/NSIC certificate with the Bid which does not notify it to be manufacturer of the tendered class / category of products. The OEM of the product Item is Apical Impex Pvt. Ltd. as per the attached Manufacturer Authorization Form. From the copies of executed past purchase order as attached with the bid document, the experience of having supplied GPU based Rack servers cannot be ascertained.
- b. For the above (a), an exemption under public procurement policy as a prequalification criterion cannot be allowed to traders / resellers of the product item chose to bid.
- c. Tender Fee of Rs. 1,180/- was not submitted. As per bid document, the firm registered with NSIC/MSME as manufacturer for the supply of the same category of item is only exempted from submission of Fee (Ref: Tender Fee Details on Page No. 07 of the Tender document).
- d. The technical literature of the GPU server does not match with the offered server model/ make as pronounced in the MAF; additionally, the server details as per the technical literature provided does not suit to accommodate the

requested configuration. The technical details of actual product quoted including the GPU co-processors are missing. No Un-Priced bill of Material was found to be attached.

Hence; the bid is declared as 'Technically dis-qualified'.

Recommendations:

As none of the bids had technically qualified, this process is declared as infructuous. It is recommended to proceed with the fresh call for bid invite retaining the product / item specification.
