1	Tender includes specification for Helium Liquefier, Purification and Storage. But there is no mention of Helium recovery system part.  According to us with Helium Recovery system just a Helium Liquefier and Purifier and storage will not be helpful and complete. So, please give us broad specifications of Helium Recovery system and whether this needs to be quoted / offered.	IISER Pune would be installing a Helium recovery system on site. However, this would be done separately, and is beyond the scope of this tender. Hence the vendor need not quote for the Helium recovery system.

1.	Can we quote three year warranty with separate prices and can be chosen and added and gives flexibility. While we are willing to give 3 year warranty please consider PBG of only one year.	Warranty prices can be shown separately. Accordingly PBG should be submitted for three years not one year for three years of warranty period.
