1	Liquid nitrogen transfer lines: Piping required within SMPV area or up to the lab area.	Piping shall be limited in SMPV area only with proper outlet valves and fittings to fill the dewars of pressurized and non-pressurized types.
2	Application: Only liquid nitrogen shall be used or the conversion to gaseous form is also needed.	The application is limited to liquid nitrogen only
3	Fire Safety: Fire safety equipments to be supplied by vendor or IISER	Fire safety equipments (fire extinguisher etc.) shall be in IISER's scope

4	Tanks capacity:	As the requirement is for two different locations
	Tanks capacity required by IISER is 1000 Its x 2 nos. It was proposed that instead of this one 6000 Itrs should be installed.	within campus, so the installation at two locations is necessary.
