Technical Qualifying Criteria

The bidder should carry out below listed bench mark programs:

- 1. HPL 2.2 benchmark (see http://www.netlib.org/benchmark/hpl/)
- 2. GROMACS (<u>www.gromacs.org</u>) benchmark. For this, the benchmark files in tar, zipped form may be obtained from the following website. Please download, untar and follow the instructions carefully. https://drive.google.com/drive/folders/0Bw FWdWPlasXME9Scmxia29XYmM
- The HPL and GROMACS benchmarks should be carried out using all 32 cores available on a <u>single</u> node.
- For the HPL benchmark, we will consider the ratio of the sustained vs. theoretical peak.

A following criteria would be used for technically qualifying the vendors.

- 1. A minimum of 73% is acceptable for the HPL benchmarks.
- 2. If (1) is satisfied, the benchmarks for GROMACS will be considered. Vendors will be considered further for benchmark comparisons in terms of efficiency. Only those vendors whose benchmark results are within 10 % of the best one will qualify for the commercial bid
