2	Warranty The tender requires a warranty of 5 years. We request that the warranty be limited to a period of 3 years instead of 5 years. Post 3 year warranty period Annual Maintenance Services can be offered as per the tender documents. We have close to 150 installations of products in India and they have proven reliability over many years of trouble free operation.	Warranty clause amended to : The warranty period is amended to 3 years period.

3	Security Deposit / Performance Bank Guarantee Performance Bank Guarantee (PBG) will be issued for 10% of the order value valid for 36 months + 60 days only. The said PBG will be issued by principal through their above-mentioned bank. Our principal will not issue a PBG for a longer period and we request your acceptance for this and submission of PBG only after completion of installation. 	S. No b) User selectable Mode of operation for response times: Multiple mode option for response times (high, medium and low gains) should be available to cover broader range of binding reactions, and allow fast re-equilibration between injections."

	Necessary Accessories: Accessories for sample degassing should be provided or options based on the system configurations for avoiding air bubbles during operation should be specified.	Necessary Accessories - The sample degassing should be quoted separately as optional item.

TA Instruments Submission: It is not clear if the system needs to be quoted along with the sample degassing accessory. In every ITC experiment the sample needs to be degassed before the experiment. It is necessary that everyone quote their degassing accessory.	While evaluating L1 the optional accessories will not be considered.
